**PURPOSE OF THE PROCESSING OF PERSONAL DATA**

The processing we carry out of your personal data serves the following purposes:

- 2.Inform about new products, services, promotions and invitations to events that may interest you by using one of the existing physical and electronic means and those that may occur in the future.
- 3.-Conducting contests or raffles for special promotions or campaigns.

**How long your data will be kept**

Your personal data will be kept for the duration of the commercial relationship between us, to ensure administrative, commercial, logistics, customer service and quality control. Once this operation is completed, the personal data will be stored within the 6year time limit established for commercial purposes by the Commercial Code and the 4year time limit established for tax purposes by the General Tax Act. For the purpose of informing you about new products, services, promotions and invitations that may be of interest to you, the data will be kept until you exercise your right of deletion. And in the case of the data collected during competitions or raffles, and to dispose in case of any complaints or contests, your personal data will be kept up to 1 year after the holding of the contest or raffle.

The data may be retained for as long as any type of liability arising from a legal relationship or obligation or from the performance of a contract or the application of pre-contractual measures requested by the data subject may be required. In this case, the data will be blocked, but not deleted.

### **Automated decision making and profiling.**

We inform you that there are no automated decisions, including profiling.

### **LEGITIMIZATION AND DATA COLLECTED**

The legal basis for the processing of personal data is the contractual relationship that binds us to our customers and for the purposes of carrying out administrative, commercial, logistic, customer service and quality control management.

The legal basis for informing you about products, services, promotions and invitations, as well as for raffles and contests, is your consent given by means of an expression of free and specific will.

The hiring of the customer of any product or service offered by the managers, whether via the website, a physical document or by telephone; the granting of consent to receive information on new products, services, promotions, invitations to participate in events or raffles and contests; or the sending of emails to the managers, via the accounts activated for this purpose, implies that the user declares that he has read and expressly accepted this privacy policy, and gives his unequivocal and express consent to the processing of his personal data in accordance with for the stated purposes.

### **USER RIGHTS**

Any interested person has the right to obtain information on the processing or non-processing of personal data concerning him. In certain circumstances, interested parties may request the restriction of the processing of their data, in which case we will only keep them for the exercise or defense of claims. The data controller will stop processing the data, except for compelling legitimate reasons, or the exercise or defense of any claims.
